

This webinar discusses how to best use the Society of Broadcast Engineers (SBE) Self-Inspection Guides. The SBE Self-Inspection Guides are produced in partnership with the National Association of Broadcasters (NAB) and other subject matter experts. The first Guides were made available in 2024. These Guides aid the broadcast engineer and senior station management in the process of inspecting their station to ensure compliance with FCC Rules and Regulations. The FM Broadcast Station Self-Inspection Guide and the Television Broadcast Station Self-Inspection Guide were the first of the guides to be released. The AM Broadcast Station Self-Inspection Guide along with that LPFM (Low-Power FM) Broadcast Station Self-Inspection Guide followed later with their own releases.






Typical Site


